# **HS2 Update**

## **Chiltern Tunnel progress update**



Our Tunnel Boring Machines (TBMs), named Florence and Cecilia, ended their journeys through part of the Chiltern Hills earlier in spring this year.

The first machine began tunnelling in May 2021 and over two and a half years later, on 7 February 2024, Florence broke through at the North Portal in South Heath, near Great Missenden, having safely completed her 10 mile journey. She was followed by Cecilia on 26 March 2024.

Between them, the two 2,000 tonne machines have built the twin bore tunnel at depths of up to 80 metres and excavated three million cubic metres of chalk. Each machine operated like an underground

factory, able to excavate the tunnels and line them with 56,000 pre-cast concrete tunnel segments, grouting them into place and moving forward at an average speed of 16 metres per day.

A crew of 17 operatives kept the machines running, working in shifts and supported by over 100 people at the main compound, managing the logistics and maintaining the smooth progress of the tunnelling operation.

#### Tunnel facts and figures

- · Diameter of cutterheads 10.26m
- · Internal diameter 9.1 m
- · Length of tunnel boring machines 170m
- · Weight of each machine 2,200 tonnes
- Average distance mined each day 16m
- Best production figure (Oct 2023): 44m in one day, 232m in one week, 842m in one month
- Five shafts
- · 38 cross passages between each tunnel bore
- Chalk from the tunnel is being used to create 127ha of chalk grassland at the South Portal. This area is called the Western Slopes and will be a new public amenity around the operational railway.

# Align starts works on C1-North

On 8 July 2024 Align JV began work on the South Heath Cutting, in addition to the works that are already underway building the porous portals and ancillary building.

The works in South Heath mean that Align is now the contractor responsible for delivering approximately 1.2 million cubic metres of cut and fill earthworks, three bridges and two culverts, between the North Portal of the Chiltern Tunnel and Leather Lane.

Align will be working closely with HS2 Ltd, Buckinghamshire Council and the local community representatives to deliver a design ready for construction which takes account of concerns about specific environmental impacts of the railway on the local bat populations and established trees near Leather Lane.

Piling for the foundations of the two overbridges GMI/2 and GMI/12 is now underway with earthworks commencing in August.

Align will be sharing the updated designs for the new Leather Lane green bridge at our public engagement events in autumn 2024. Completion of these works is planned for June 2027.

# **Changes to boundary fencing in C1-North**

Now that earthworks have commenced, we are upgrading the site fencing and security to better secure the site and protect the public.

Works to improve the existing site 'post and rail' fencing around the boundary to rigid mesh security fencing began in July and will be completed by the end of September.

The site hoarding that is already installed will remain unchanged.

### **Footpaths**

There has been no change to the footpath arrangements in this area.

As a reminder, this is the current status of the footpaths in the area from the South Heath Cutting to Leather Lane:

GMI/2 is open

GMI/12 is currently closed

GMI/13 is currently closed

## Site progress at our tunnel portal and shaft sites

With tunnel boring operations now complete, works to finish the structure of the operational buildings above the five ventilation/intervention shafts continue.

The pictures below demonstrate how the building work above ground is progressing. Chalfont St Peter will be the first of these operational buildings to be finished, early in 2025. These structures will house ventilation equipment and systems that will maintain airflow through the Chiltern Tunnel, as well as providing access to the tunnel below for maintenance and emergency services.

## South Portal (near West Hyde, Herts)

Work at the South Portal site continues to create the porous portal structures which will dissipate noise and air pressure at the southern entrance to the 10 mile long tunnel.



#### **Chalfont St Peter**

Chalfont St Peter is the most advanced in programme of our ventilation shaft sites. Work to create the main building metal deck has been completed, and work continues on the fitting of internal doors and fittings.



#### **Chalfont St Giles**

External cladding works have now been completed on the headhouse and ancillary buildings above the Chalfont St Giles ventilation shaft.

#### **Amersham**

Waterproofing works (pictured right) are underway on the tunnel and ventilation shaft connection beneath the surface.

Above ground we will dismantle and remove the tower crane at our Amersham vent shaft site from 5.30am on Saturday 11 August 2024. Works will continue across the weekend and are expected to be finished by 8pm on Sunday 12 August.

To carry out the removal of the crane safely, a full road closure of Whielden Lane between Whielden Street and A404 will be implemented.





#### Little Missenden

Construction of the main and ancillary building at Little Missenden is ongoing, with walls and roofs to be completed by August.



## Chesham Road (intervention shaft)

Structural steel works are underway for the site buildings. Firefighting facilities are due to be installed in the next few months for future emergency service access.

#### **Site visits**

We have hosted many visits this year at our shaft sites with a range of stakeholders. Students, village associations, and residents are amongst some who have attended site and had the opportunity to engage with site engineers who were pleased to share their knowledge with interested parties.
