

# Cross passage construction near Rabournmead Park

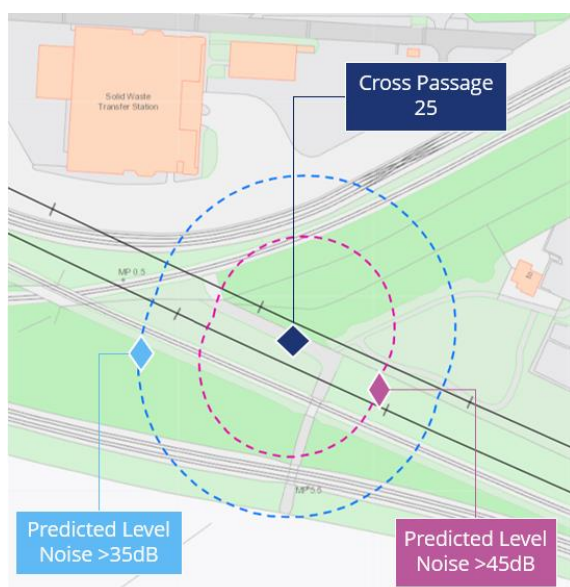
High Speed Two (HS2) is the new high speed railway for Britain.

## Cross passage construction

From **5 October to 2 November 2024**, we will be constructing cross passage 25 near Rabournmead Park. During this time there will be a five-day period of noisy work.

Cross passages between the HS2 rail tunnels will allow HS2 passengers to get to a place of safety in an emergency, and are approximately 500 metres apart along the route. This cross passage is about 20 metres below ground, and about 100 metres from the closest property.

Cross passage construction involves breaking into the side of the completed tunnel. This might generate some noise and vibration which may be heard/felt as ground borne noise in nearby buildings when transmitted through the ground to the surface. The map below shows the location of cross passage 25.
