## Notice of reinstatement works, Eastcote Lane, Northolt

High Speed Two (HS2) is the new high speed railway for Britain.

#### What we are doing

From **16 to 20 September 2024**, we will be carrying out the final touches to the reinstatement work along Eastcote Lane and Moat Farm Road in Northolt.

The work includes:

- Road mark painting
- Replacing gas lids
- Installing gas marker posts
- Rebuilding the wall at Northolt Park Baptist Church

#### How this work might affect you

Temporary traffic management will be in place to ensure these activities can be carried out safely.

There will be a partial road closure on Moat Farm Road at the junction with Eastcote Lane.

There will be a lane closure on Eastcote Lane from the church to No. 128.

For access to Moat Farm Road at the junction of Eastcote Lane, traffic will be diverted along Eastcote Lane and Mandeville Road.

The work areas, lane and road closures and diversion routes are indicated on the map on the next page.
