High Speed Two (HS2) is the new high-speed railway for Britain.

What we are doing

On **Sunday 6 October 2024** we will be carrying out road reinstatement works on Oldfield Lane North in Greenford.

These works include road resurfacing, applying anti-skid material and road marking.


How this work might affect you

There will be two partial lane closures on Oldfield Lane North, with twoway temporary traffic lights in place at each work site.

There will be temporary suspensions to bus stops MM, ZI and JJ. Please plan ahead of any travel using buses in this area during the works. You can find the latest bus status updates via www.tfl.gov.uk/plan-a-journey.

Some works may be noisy, but we will use noise reducing barriers to minimise impact where possible.

The work areas, partial lane closures and bus stop suspensions are indicated on the map below.
