# **Crane delivery via Stanhope Street gate – Saturday 28 September**

We require a crane to be delivered to our site to assist with ongoing works in the Euston Scissor Box. The crane will be delivered between 9am and 10am on Saturday 28 September.

Due to other work being carried out within site, we cannot deliver the machinery via our usual Hampstead Road access gate and will need to do so via the Stanhope Street access gate.

We will suspend five parking bays outside Cubitt Court, to park our low loader vehicle. We may need to temporarily hold traffic to allow the vehicle to enter our site.
