
# Work we are completing

As part of our ongoing work constructing the new HS2 line within the area, we need to complete some utility diversions nearby, ensuring services are maintained.

To enable us to divert Virgin Media and BT cables that run underneath Thompson Way, we will be closing the road and footpath for two weeks. During the closure, there will be no access for vehicles or pedestrians as the road is too narrow to excavate a single lane at a time safely.

The closure will be in place from **Monday 30 September until Monday 14 October,** 24 hours a day, 7 days a week due to extent of the excavations required. Our working hours will be 8am until 6pm Monday to Friday, and until 1pm on Saturday, but we may be onsite up to an hour before and afterwards.
