



Leather Lane road closure, Great Missenden / The Lee, for vegetation maintenance works

High Speed Two (HS2) is the new high speed railway for Britain. This notice is to update you on a temporary road closure of Leather Lane, Great Missenden / The Lee so that we can undertake some planned vegetation maintenance.

How will these works affect you?

Leather Lane will be temporarily closed to traffic from 9.30am to 3.30pm, after which the traffic management will be removed

- 1 October 2024

Traffic will be diverted via Potter Row, Frith Hill, and Aylesbury Road (A413) during the closure. Please see the map below.

The farmer's access will be maintained.

What will we be doing?

A trained ecologist will inspect the area prior to any works starting to ensure the area is free of wildlife and nesting birds. Once authorised, a small team of operatives will be visible on the highway with handheld machinery, such as strimmers and hedge cutters who will cut back overgrown grass and weeds, and trim back any overgrown hedges from Cottage Farm to Potter Row.

HS2 commitments

HS2 has a commitment to Buckinghamshire Council which states that Leather Lane cannot be closed at the same time as Rocky Lane and Bowood Lane, unless the requirements have met the reasonably practicable request. As it is unsafe to for our operatives to work in the single lane highway with live traffic Leather Lane will be temporarily closed to traffic and cyclists and has been agreed by Buckinghamshire Council.

1 October from 9.30am to 3.30pm

- Fully signed diversion route via Potter Row, Frith Hill South Heath Leg, and the A413
- Operatives visible and working in the area

- Inform local Parish Councils, village associations and residents
- Maintain access for the farmer from the western side of Leather Lane

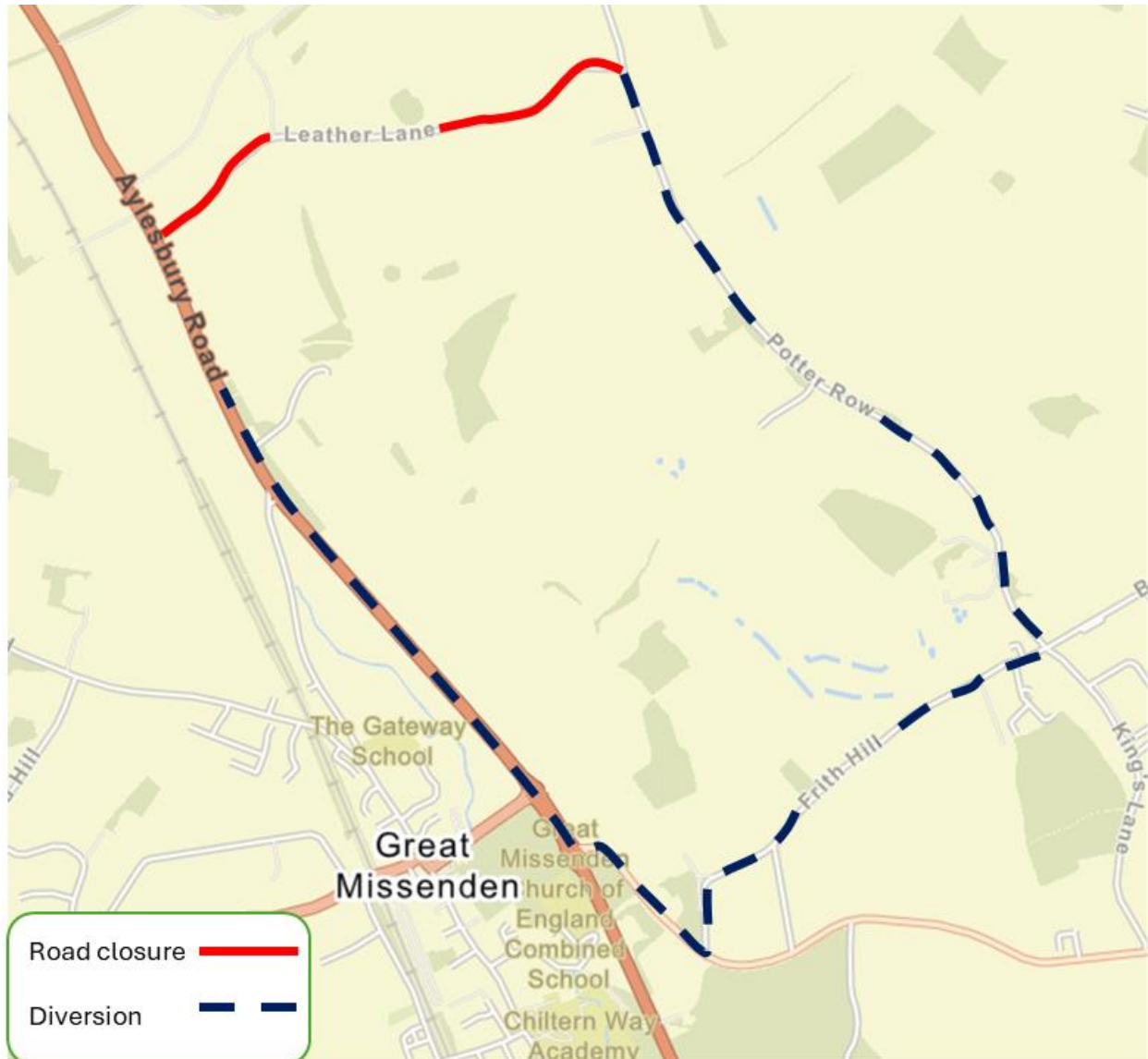
