What are we doing?

From 23 September 2024 until 11 October 2024 a section of Addison Road will be subject to a lane closure under 2-way temporary traffic lights. This is to construct a new footpath and gully installation.

This is for reasons of safety, as our operatives are working on and around the carriageway.

When will these works take place?

Addison Road will have a lane closure, with temporary traffic lights in place from 23 September 2024 until 11 October 2024.

These dates may change due to conditions outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes and updates.

Duration of works

A section of Addison Road will have a lane closure from 23 September until 11 October 2024 and 2-way temporary traffic lights will be in place.

Normal working hours:

Monday to Friday 8am-6pm
Saturdays 8am-1pm

Please note there will be an hour set up and close down either side of the above hours.



The map below shows the lane closure on Addison Road that will be in place from 23 September to 11 October 2024, managed by 2-way temporary traffic management. The existing Addison Road closure remains in place until 14 October 2024 and Calvert Road closure until Summer 2025.
