What are we doing?

In 2 to 4 October 2024 there will be 2-way temporary traffic lights on Main Street, Charndon. Traffic management is required to regulate traffic flow over the narrow bridge while this route is being surveyed and made safe in time for being used as a diversion route during the upcoming realignment of Gawcott Road.

Gawcott Road is planned to close in mid/late October. An advanced works notice will be issued for the Gawcott Road closure once repairs to Main Street are complete, and a final date has been confirmed.

When will these works take place?

Traffic management will be in place from 2 - 4 October 2024 until March 2025 when the planned Gawcott Road works will be complete.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Main Street will have traffic management from Wednesday 2 October 2024 to 4 October 2024.

Respond promptly to any complaints and take appropriate action.


Notice of Traffic Management on Main Street, Charndon
