What are we doing?

This autumn we will be continuing with earth works around the Princes Risborough to Aylesbury railway line, which we diverted last year. The area remains an active worksite while we complete earth works and drainage works alongside the line.

We will be temporarily closing a section of the SMA/18/1 public right of way to enable these works to continue. This is due to safety reasons while our operatives will be excavating in and around this area. This work was originally planned to begin during September but has been delayed due to site access constraints related to our other works in this area.

When will these works take place?

SMA/18/1 will be closed:

- **24 hours a day from Sunday 20 October to Saturday 9 November** (previously Monday 23 September and Sunday 13 October)

These dates may change due to conditions outside of our control. Please refer to the HS2 website regularly to check for any changes and updates.

Provide updates for communities and maintain regular contact points for the duration of the work

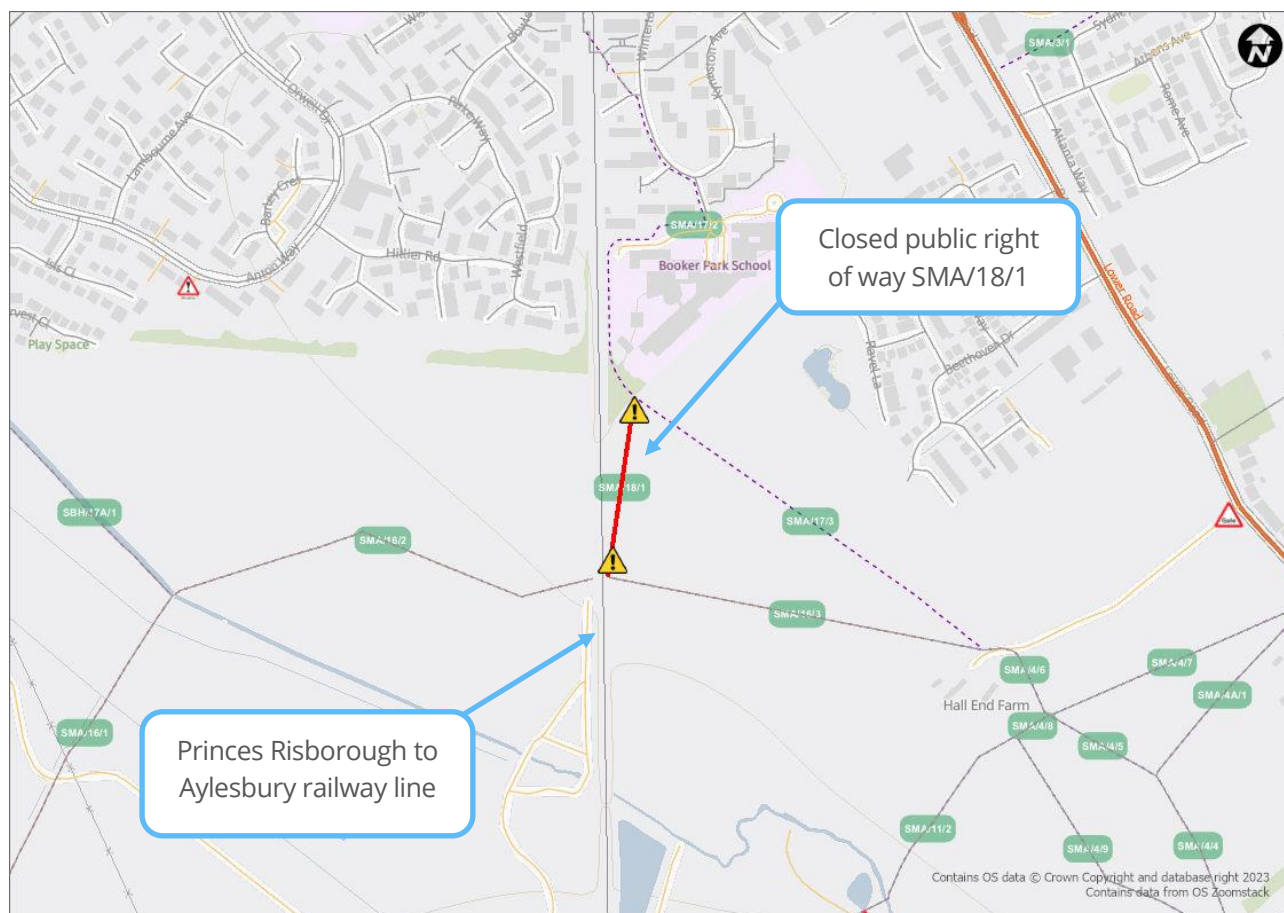
