



Notice of the dismantling of the **Colne Valley viaduct launching** girder

High Speed Two (HS2) is the new high speed railway for Britain. The Colne Valley viaduct is made up of 1000 segments, placed in sequence, and the last one is due to go in, in the first week of September 2024. The launching girder which has built it will then be dismantled.

Works taking place at the South Embankment

The Colne Valley viaduct takes the HS2 railway across three lakes and the River Colne and is just over two miles long, making it the longest railway bridge in the UK. The launching girder used to construct the viaduct started its journey in spring 2022 from the North Embankment near Denham Waterski Club in Buckinghamshire and has now reached the South Embankment site off Harvil Road in Hillingdon. The girder will install the final segments in early September, and it will then be dismantled. The girder weighs 700 tonnes, is 160 metres long and works to take it apart will take several weeks. To dismantle the girder safely at the South Embankment, works will take place 24/7 – Monday to Sunday - from Monday 16 September through to Friday 25 October 2024. Work will take place 24/7 - Monday to Sunday

What to expect

There will be some noise, such as the cutting of steel, associated with the work to take the launching girder apart, and a 160 tonne tall crane will be used as part of these works

What we will do

We will monitor noise on site, to ensure it does not go above consented levels and do all we can to minimise disruption.

What will be taking place?

Once the final concrete segment is in place at the southern end of the viaduct, the launching girder will be moved backwards slightly onto a platform and will need to be jacked up and its main supports removed before being lowered onto concrete blocks. As this operation can be disrupted by wind, it will need to be held in place and to ensure it is rigid before the sections of the launching girder can be safely removed. The removal of each section will be done using a large crane weighing 160 tonnes and each section will take some days to remove safely each time.
