



Notice of temporary closure of the B4114 Birmingham Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

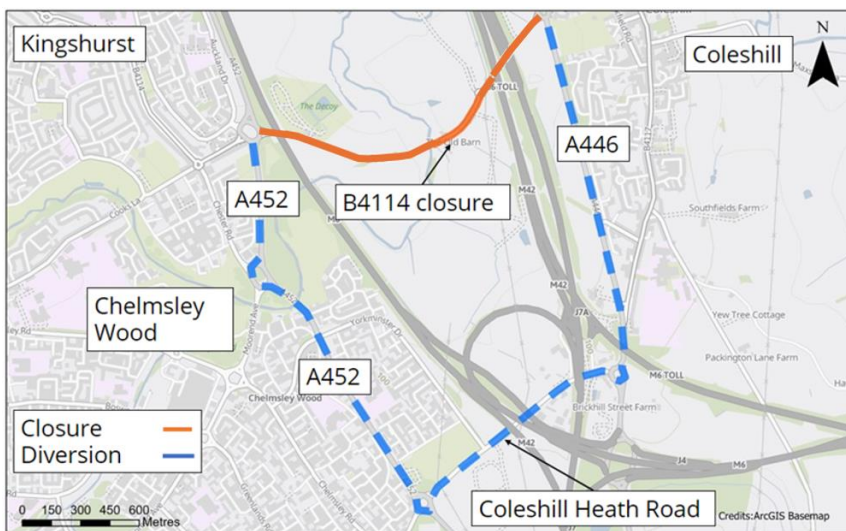
To continue our preparation for the construction of the HS2 railway, we will install a temporary bridge over the B4114 Birmingham Road. The closure will allow for the work to be carried out over the carriageway, which includes lifting the bridge sections into place.

When the work will take place

To complete these works safely, we will install a weekend closure of the B4114, Birmingham Road between the South Drive roundabout and the A452 Collector Road. The works will take place from 6am on Saturday 28 September to 6pm on Monday 30 September.
