Have all practicable means to negate need for works to tree been investigated? Please provide details Under the instruction of the arboriculturist, undertake formative pruning of the regrowth from the stumps to encourage vertical growth.

The main aim of formative pruning is to produce a tree which in maturity will be free from any major physical weaknesses (BS 3998:2010 Tree work – Recommendations)

The formative pruning will predominantly focus on the removal of horizontal, lateral branches to promote apical dominance; however, it may also be prudent to thin some stems from the stumps to concentrate growth on fewer main stems. This helps direct the plant's energy towards vertical growth and fewer strong shoots.

The exact branches to be pruned will be decided on site based on the competent advice of the arboriculturist.










Diagram No.1: Location Plan 1
