



## UPDATED: Notice of temporary traffic lights on B4117 Gilson Road

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

### The work we will be doing

To assist in our preparation of the construction of the HS2 railway, we will be removing vegetation along sections of Gilson Road. To conduct our works safely, we will install temporary traffic measures in the area to ensure the safety of road users and our workforce.

### When the work will take place

**Update:** Due to changes in the works program and to complete the works safely, we need to extend the traffic management in place on Gilson Road to Friday 18 October. Our working hours will from 9:30am to 3:30pm each day.

Our workforce may be on site up to an hour before and after those times to set up and close down the site.
