High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

#### The work we will be doing

As we progress the construction of the Welsh Road Overbridge and the new realignment, we need additional temporary traffic lights on Welsh Road to complete the following works:

- Vegetation clearance of verges along a section of the Welsh Road and installation of drainage.
- Installing curbs and pavements to prepare for the new road realignment.

# When will these works be taking place?

The extended works will continue from **Monday 7 October until Friday 25 October 2024**. The temporary traffic lights will be in place 24 hours a day over this period.
