# **Update: reinstatement** works, Greenford Road

# **Slabbing Works on Greenford Road**

We wrote to you in September to let you know that we were carrying out the final phase of reinstatement work on Greenford Road, Greenford. These were expected to be completed by 28 September 2024.

Due to recent heavy rain, we were unable to complete the slabbing works on Greenford Road eastern footpath from Bennetts Avenue to McDonalds. These works are now expected to be carried out from **11 to 14 October 2024**, weather dependant.

# How this will affect you

The works will be completed on the footpath which will be narrowed but will remain open.

The welfare cabin will remain at Bennetts Avenue as well as the road closure, until the Thames Water works on Greenford Road have been completed so that we can manage traffic effectively. We estimate these works will be completed by early November
