### Notice of overnight closure on A425 Leamington Road, Southam

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

#### The work we will be doing

We will be undertaking carriageway repair and vegetation clearance on the A425 Leamington Road to enable the construction of the new green tunnel and various utilities realignment.

#### When these works will take place

An overnight road closure on the A425 Leamington Road will be in place on Monday 11 and Tuesday 12 November 2024, from 8pm to 6am. A signed diversion route will be in place (please see map on page 2), please allow additional time for your journey.

We will maintain access to homes and businesses at all times during these works. Also access to properties within the closures for cyclists and pedestrians will be maintained.

Our workforce may be on site up to one hour before and one hour after to set up and secure our equipment.


