#### What we are doing

Between 28 April to 18 May, we will be working along Harvil Road between Skip Lane and the Dogs Trust to carried out some planned snagging works.

Harvil Road will be closed overnight to allow the following activities to be carried out safely:

- drainage cover repairs on the carriageway,
- white lining (weather dependant),
- sealant works on the parapets on the new bridge along Harvil Road,
- snagging works along the footpath on Harvil Road to repair paving defects and cracks. Footpath diversion will be in place for

These activities are non-intrusive, with a minimal noise level expected ensuring that any disruption is kept to a minimum.

## How these works will affect you

**From 28 April to 18 May 2025**, Harvil Road will be closed overnight north and south of the new Harvil Road bridge over the Chiltern Line, Sunday to Thursday from 11.59pm to 5am, Friday and Saturday, from 9.30pm to 6am.


A clearly signed diversion route will be in place via Moorhall Road / A412 / A40.

For safety reasons, a temporary road closure will be in place. However, this will be removed at the end of each shift. A partial footpath closure and a diversion will be in place during the day maintained by traffic marshals.

During the road closure, local access to residential and commercial properties (including the Dogs Trust) will be maintained, however, there will be no through access for emergency services. These activities will be carried out along and around the footpath on Harvil Road. A footpath diversion will be in place and maintained by traffic marshals.


