## Hampstead Road southern section update – 21 October to 17 November 2025


Following our site safety stand down, we have now begun a safe restart of works across our worksites in Euston Approaches. We are continuing our programme of utility diversion works in the southern section of Hampstead Road, near Varndell Street.

On **21 October** we will move to the next phase of our programme. We will continue to close the southbound lane on Hampstead Road, and Varndell Street will remain closed.

Cardington Street will also be closed. Vehicle access to Regent’s Park estate will be via Robert Street.

We will maintain two way traffic on Hampstead Road using temporary traffic lights. Please see footpath diversions and crossing points on the map below.

We will continue to monitor the traffic management and reduce impacts where possible. We apologise for any inconvenience these works may cause.

## Next phase from 17 November to end of December 2025


From **mid-November to the end of December**, the southbound lane on Hampstead Road, and Varndell Street will remain closed.

Cardington Street will also remain closed and pedestrians will be diverted through the carriageway and worksite.

Vehicle access to Regent's Park estate will be via Robert Street.

We will maintain two way traffic on Hampstead Road using temporary traffic lights. Please see footpath diversions and crossing points on the map below.
