High Speed Two (HS2) is the new high speed railway for Britain.

Training facility set-up and operation – 14 October

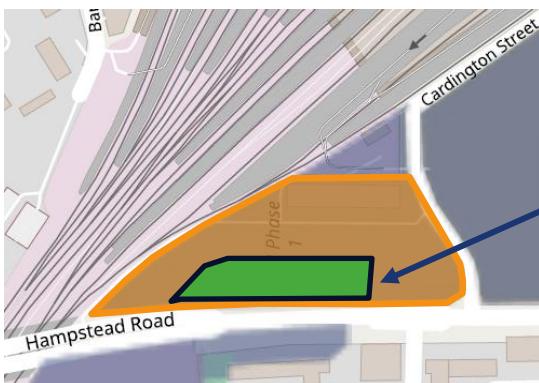
In line with direction from the Government in March 2023, HS2 rephased construction works in Euston Approaches. Since then, HS2 have collaborated with partners to identify opportunities to temporarily use spaces for the community while some construction is paused.

We will be assisting Flannery, our plant hire sub-contractor, to set up a temporary training facility within Zone 5, the area to the east of Hampstead Road. This is part of a Camden Construction Skills Centre initiative and will be used to give local residents the opportunity for practical and classroom-based experience using construction machinery. The training facility will be used from 28 October 2024 to end of March 2025, Monday to Friday 8am to 5pm.

From 14 October to help set up the area, we will install fencing within site, clear vegetation and compact the ground.

We do not expect any of these works to be noisy. We will monitor noise levels closely to ensure we are working within the approved noise limits.

We apologise for any disruption these works may cause.
