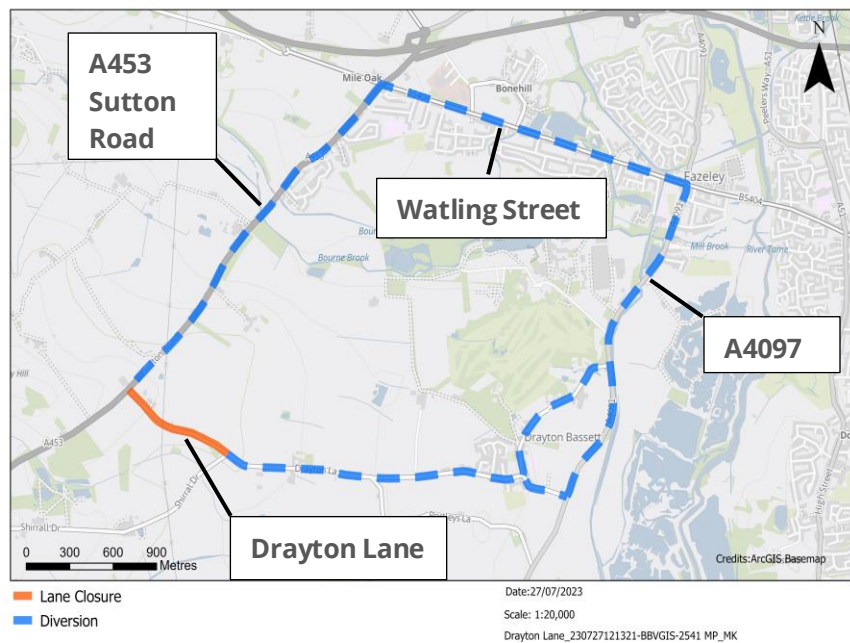
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will do

We are transporting large bridge deck beams that will form part of Drayton Lane overbridge. To complete the delivery safely we must establish a safe working area which will require the temporary closure of Drayton Lane. On completion of the delivery, we will then reinstate traffic signage and reopen the road.

When the work will take place

The delivery of the bridge deck beams will be completed on 14 October. The full temporary closure of Drayton Lane will be in place between 7pm until 6am. However, we plan to reopen the road as soon as our works have been completed.



Duration of works

Temporary overnight road closure on Drayton Lane 14 October.

Our working hours will be 7pm to 6am.
