



Notice of full closure on A46 Northbound, near Kenilworth

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area

The work we will be doing

As part of the ongoing works for the construction of the railway we require a full closure of the A46 northbound carriageway. This is to enable the removal and repositioning of the safety barriers back into the verges. Works will take place overnight for one night. The road will be re-opened once the safety barriers are in place and will remain in place until February 2025.

When will these works be taking place?

The A46 Northbound will be closed on **Friday 25 October, between 8.00pm and 6.00am for one night**. Our works will involve a full closure on the northbound carriageway between the Thickthorn Interchange (Leamington) and Stoneleigh Junction.

What to expect

We will install a fully signed diversion for HGVs via the **M6, M42 and M40 then rejoining the A46**, please see the map on page 2.

The local diversion route will be the **A452, Bericote Road, Westhill Road, Leamington Road, A445, A423, A45 and then rejoining the A46** please see page 3.

The closure is subject to consent from National Highways

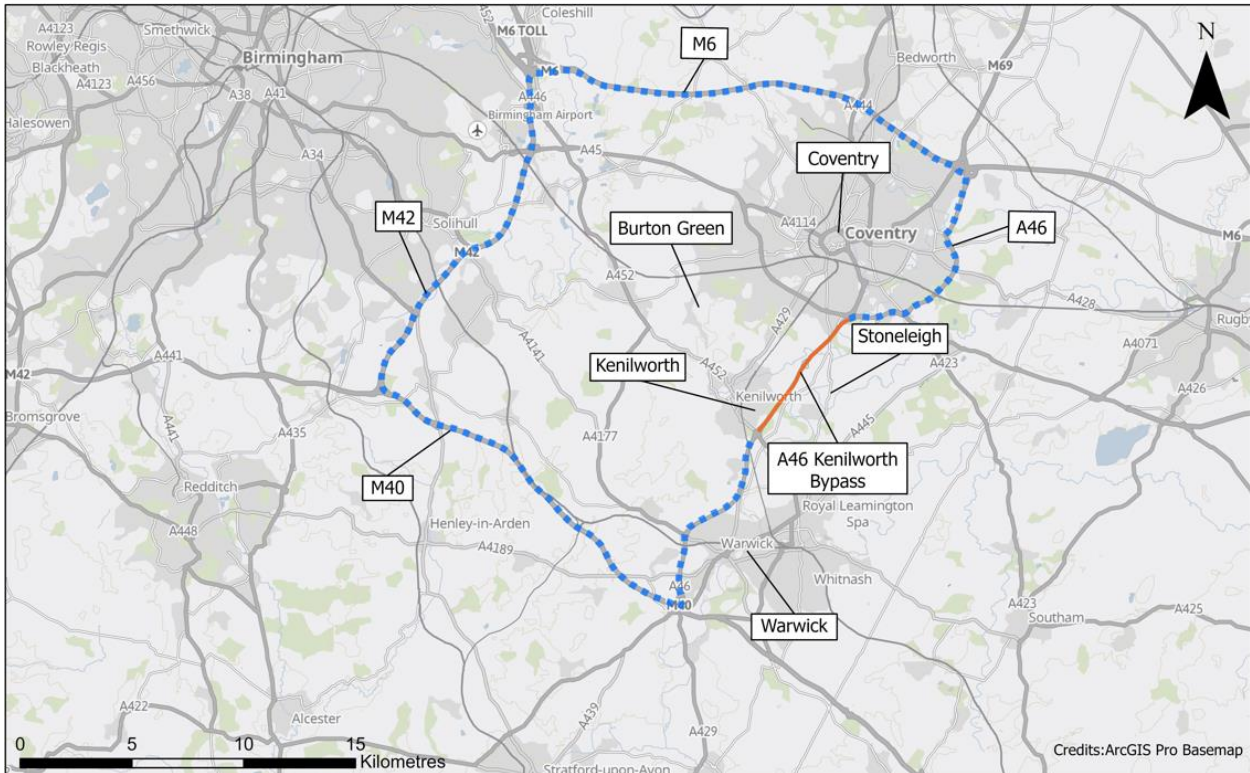

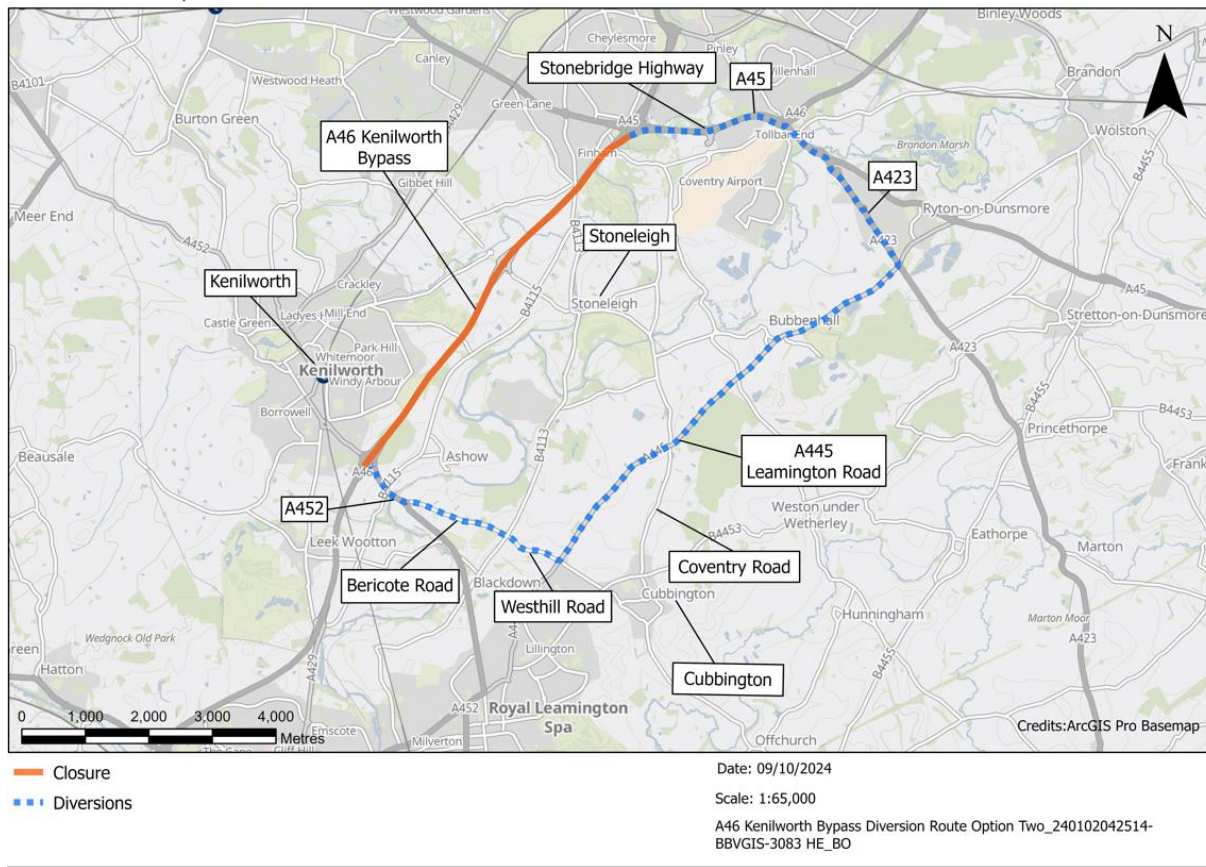
