High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Installation of Bentonite Pipes

Ahead of constructing the new HS2 structures in Birmingham, there will be temporary traffic lights on Duddeston Mill Road to allow the installation of Bentonite Pipes on Monday 14 October to Wednesday 16 October 2024 from 08.00am to 4.00pm.

The footpath will be closed on one side on Monday 14 October 2024 to Wednesday 30 April 2025.

Temporary Traffic Lights

In order to carry this work out safely, we will need temporary traffic lights put in place on Duddeston Mill Road.

Pedestrian access and access to frontages will be maintained throughout.

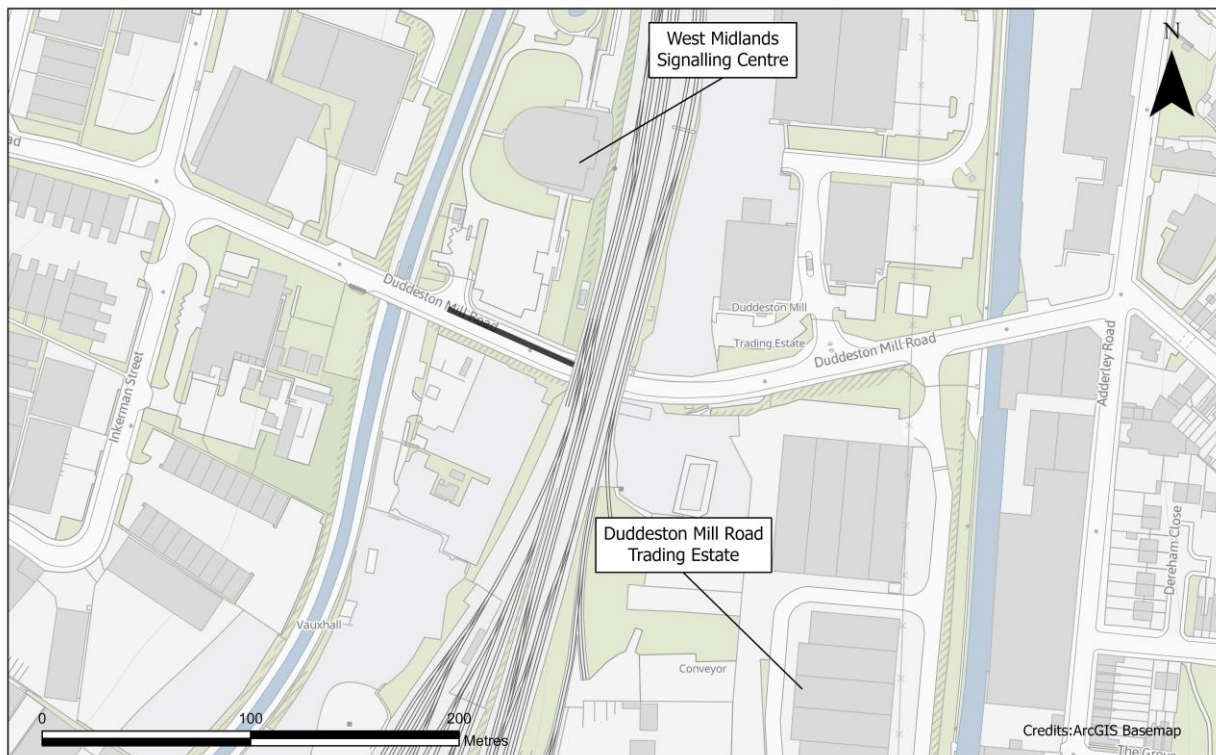
