The work we will be doing

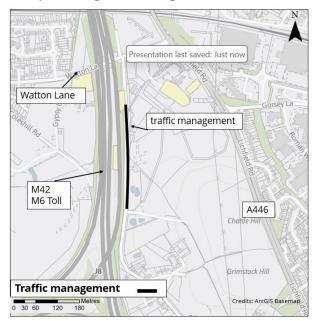
To continue our preparation for the construction of the HS2 railway, we will be working along Gilson Road to undertake emergency repair works on the carriageway.
