High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To prepare for our continued construction of the HS2 railway Severn Trent Water will be undertaking utility works on Gilson Road. These works will include trail hole investigations for the Severn Trent mains. Once complete, the road will be reinstated and reopened. Traffic management will be installed to ensure the safety of the workers and public to complete the Severn Trent works.

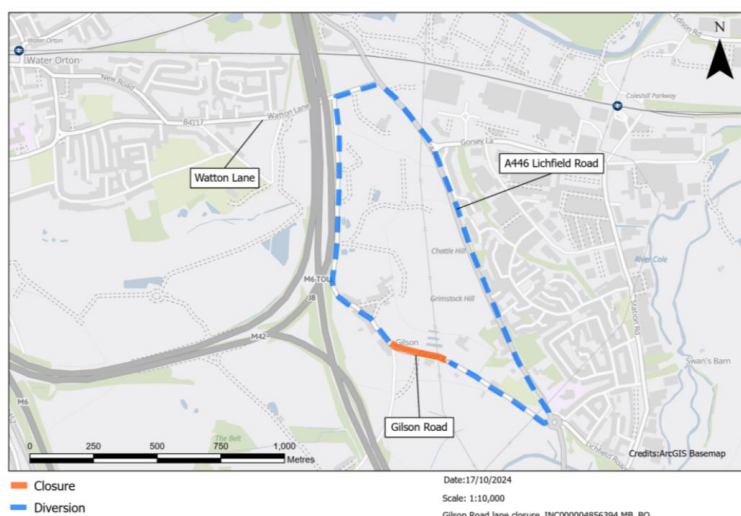
When the work will take place

A road closure will be in place on Gilson Road from the junction of Gilson Drive to the old Grimstock Country House Hotel. The closure will be in place on Sunday 3 November from 8am to 6pm.

All vehicles will be directed to use the diversion in place. Pedestrian access will be maintained.

A road closure will be in place on Gilson Road on Sunday 3 November from 8am to 6pm.
