High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

CCTV Surveys

Ahead of constructing the new HS2 structures in Birmingham, we will be carrying out CCTV Surveys on Lawley Middleway on Monday 21 October to Friday 8 November from 10.00pm to 05.30am

Lane Closures

To enable us to carry out these works safely and effectively, we will need to close one lane northbound and one lane southbound from the section of Curzon Circle roundabout to Garrison Circus roundabout. We will then switch the closure to the alternative lane in both directions. One lane northbound and southbound will always remain open.

Pedestrian access and access to frontages will be maintained throughout.
