What are we doing?

From Monday 14 to Friday 18 October 2024 Main Street, Charndon, will be closed 24 hours a day on the north side of the East West Rail bridge. This closure will be in place to allow road repairs to be carried out prior to this route being used as a diversion for the Gawcott Road closure in October 2024.

Gawcott Road is planned to close in mid/late October. An advanced works notice will be issued for the Gawcott Road closure once repairs to Main Street are complete, and a final date has been confirmed.

When will these works take place?

Road closure in place from 14 - 18 October 2024.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Main Street will be closed from Monday 14 October 2024 until Friday 18 October 2024.

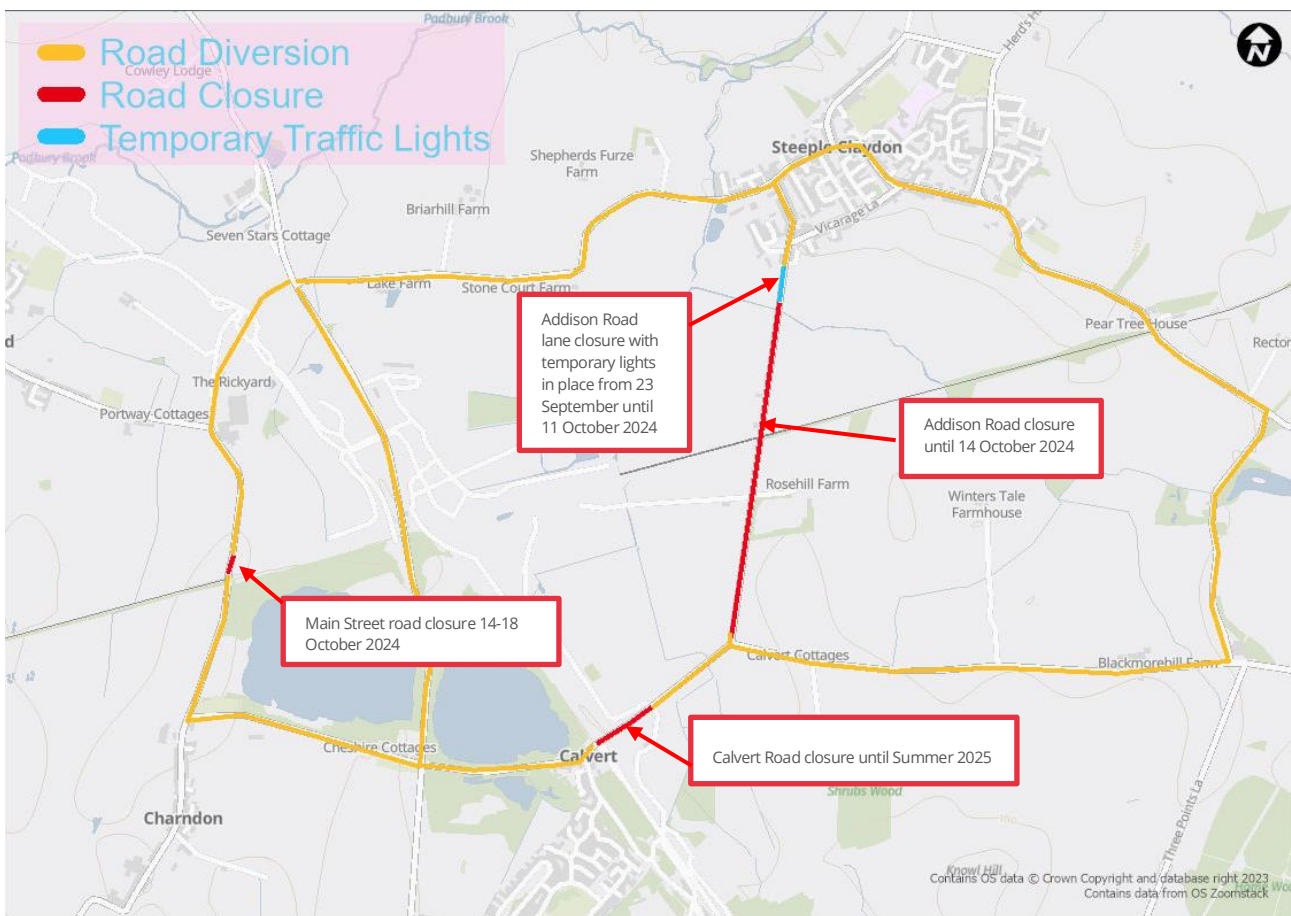
