To carry this work out safely, we will need to put in place temporary traffic lights on a section of Curzon Street, from Cardigan Street to the Curzon Circle roundabout.

Pedestrian access and access to frontages will be maintained throughout.

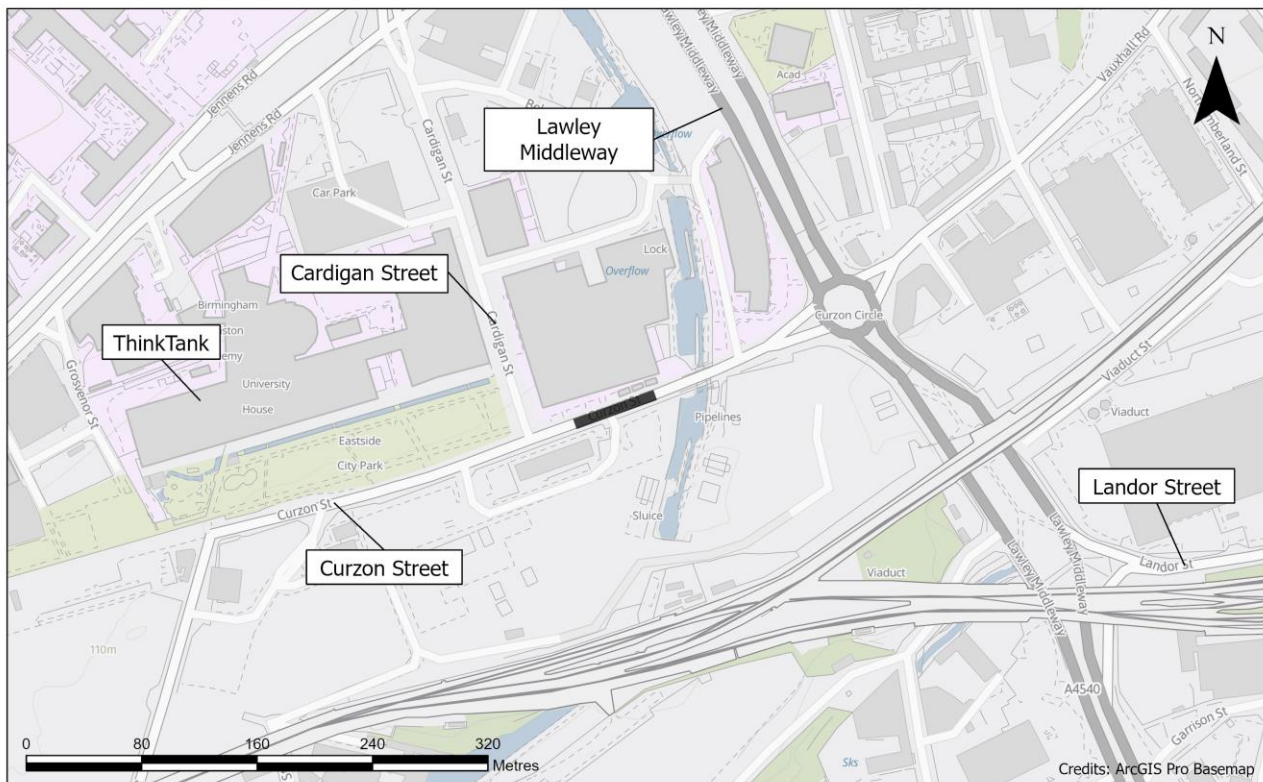
