



Notice of road closure on The Fosse, B4455, Offchurch

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing.

As part of the ongoing work to deliver the HS2 railway, we will be carrying out trial holes and GPR surveys along The Fosse, B4455. To carry this work safely, we will need to put in place a closure on The Fosse. A clearly signposted diversion route will be in place for the duration of the works.

When will these works be taking place?

The closure will be in place on **Monday 11 November to Friday 6 December 2024 between 8am and 6pm, Monday to Friday.**

What to expect

Outside of the closure times there will be 2-way temporary traffic lights operating during the weekends and overnight between **6pm and 8am**, this is to reduce the disruption to the travelling public. Access to properties, for pedestrians and cyclists will be maintained while the works are being carried out.


