High Speed Two (HS2) is the new high speed railway for Britain.

Thames Water update

We are carrying out cleaning works in the sewer on Gloucester Avenue. To do this we will need to access the sewer overnight through manholes at the following locations: Gloucester Avenue, Waltherton Road, Formosa Street and Prince Albert Road.

Our work

These are short duration **works from 11 November to 14 November between 8pm and 5am**. Noise will be kept to a minimum at all times. Works will be subject to weather conditions. We will let you know if dates change.

Gloucester Avenue - Camden

We will be working outside number 19. Traffic management will be installed each day by 8pm and removed at 5am. Three parking bay suspensions and two bus stop suspensions will be in place on Gloucester Avenue.

Waltherton Road – West Kilburn

We will be working on the junction with Lydford Road. We need to suspend five parking bays in the area on Waltherton Road.

Formosa Street – Maida Vale

We will be working in the section of the road leading to the roundabout with Bristol Gardens. We will install traffic management each day at 6pm and removed at 5am.

Prince Albert Road - Camden

We will be working on the traffic island next to St John's Wood church. There will be no traffic management in place.
