# **Update of concrete** foundation works at South **Ruislip Vent Shaft site**

## What we are doing

We wrote to you in November that we would be building a concrete base foundation for an electrical transformer station within the South Ruislip vent shaft site. We planned to finish by 13 December 2024 but due to other works on site, works will now be completed by 20 January 2025.

We will break out the original concrete, dig down one metre into the ground and refill to create the new base. We will use an excavator and a vibrating plate.

You may experience increased noise and vibration during these works. Noise and vibration monitoring will be in place. We will use water sprays to reduce dust and noise barriers to help reduce noise.

We would like to apologise for any disruption or inconvenience these works may cause.
