During late October and the start of November 2024 the crossroads of Station Road South, Quainton Road and Station Road North will be closed. There will be signed diversion routes in place.

When will these works take place?

The crossroads of Station Road South, Quainton Road and Station Road North will be closed from Monday 28 October until Friday 29 November 2024.

These dates may be subject to change due to circumstances outside of our control, such as weather.

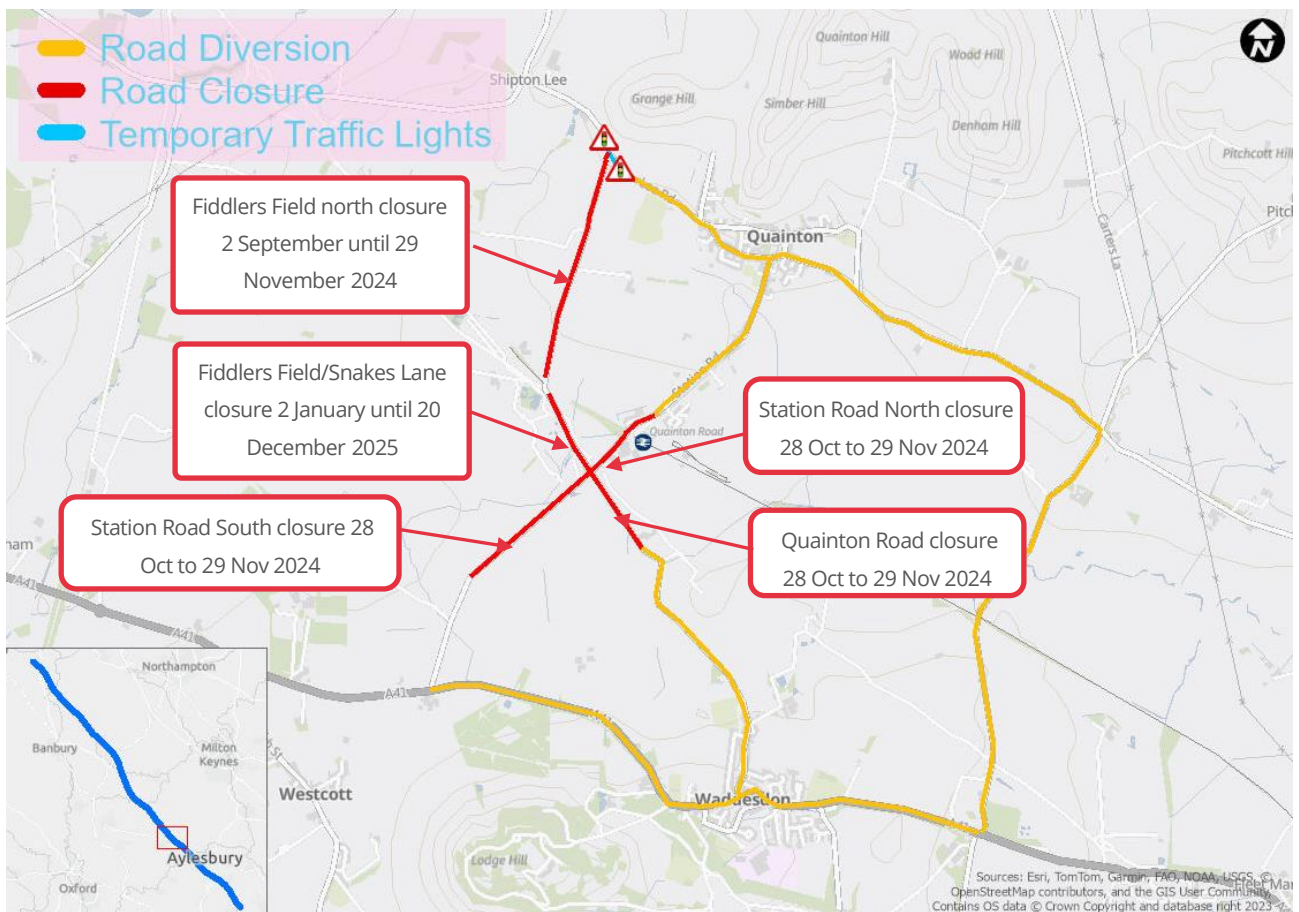
