High Speed Two (HS2) is the new high speed railway for Britain. Mace Dragados is the Construction Partner building the new HS2 station in Euston.

Maintenance to Ramp at West Colonnade

From Monday 25th until approximately Friday 29th November 2024, between 9pm and 5am (daily) we will be carrying out maintenance work to the Passengers with Reduced Mobility (PRM) step-free access ramp at West Colonnade. During these works the step access only will remain open.

Pedestrians requiring the **step-free access will be diverted** to an **alternative route via the station.** Site marshals will be available to help direct members of the public who may need assistance.



We recognise that construction work can be disruptive to those living and working nearby. The nature of our work often means some disturbance is unavoidable, however every effort is made to minimise any unnecessary noise. We always try to complete works as quickly as possible, **but please be aware the timeframe given above is a guide and that technical difficulties may mean the timings can change.** If these changes are likely to cause any disturbance, we will write to you again.

Duration of works

- Monday 25th until approximately 29th November 2024
- 9pm until 5am

What to expect

- Temporary closure of PRM Ramp for maintenance
- diversion route during working hours

What we will do

- Marshals in place to assist pedestrians
- Aim to reduce noise and vibration as reasonably practicable
- Apply dust mitigation measures
- Create temporary work sites
- Keep all sites safe and secure
