High Speed Two (HS2) is the new high speed railway for Britain.

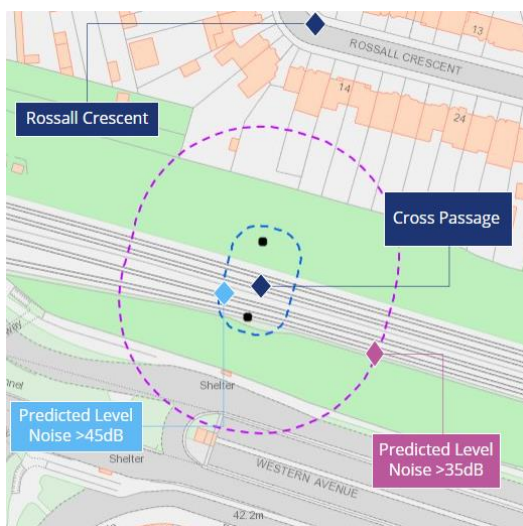
Cross passage construction works near Western Avenue and Rossall Crescent

From **1 to 7 December 2024**, we will be constructing a cross passage near Western Avenue and Rossall Crescent. We will work 24 hours, seven days a week. Within this time there will be periods of noisy works. To avoid overnight disturbance, we have agreed with the local authority to limit noisy activities to **between 7am and 10pm Monday to Sunday**, and carry out quieter works at night.

Cross passages between the tunnels will allow HS2 passengers to get to a place of safety in an emergency, and are approximately 500 metres apart along the route.

Cross passage construction involves breaking into the side of the completed tunnel. This might generate some noise and vibration which may be heard or felt as groundborne noise in nearby buildings when transmitted through the ground to the surface.

Properties that may be affected are shown within the pink and blue lines on the map below. These lines represent the predicted noise levels in these areas. This cross passage is approximately 20 metres deep and 30 metres away from the closest property.
