High Speed Two (HS2) is the new high-speed railway for Britain.

What we are doing

From **9 to 13 December 2024** we will be carrying out gas service repair works on West Gate, outside Westgate House. These works involve digging a small hole on the road to repair and restore a valve lid.

How this will affect you

There will be a lane closure with three-way temporary traffic lights and parking bay suspensions. We will use a vacuum excavator to dig the hole. We will use noise reducing barriers where possible to minimise disruption to the local community.

The approximate locations of the work area, lane closure, and parking bay suspensions are shown on the map below.
