

Notice of overnight lane closure of the northbound carriageway of the M42

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As we prepare for construction of the new M42 triple box bridge across the M42 motorway, we are commencing works to remove the current fencing as part of the safety barriers. These works will require overnight lane closures to access the works area safely.

To complete the works we will be installing weekday overnight lane closures; lanes 3 and 4 of the northbound carriageway of the connector road from the M6 at J3a to where it joins the M42, and from J7a to J8.

When the work will take place

Weekday overnight lane closures of the M42 northbound carriageway will be for three consecutive nights from Tuesday 17 December to Thursday 19 December. The closures will be in place from 9pm to 5am each weeknight.

This work is subject to consent with National Highways.
