High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty Vinci (BBV) is working in partnership with HS2 Ltd to build the new high speed railway in your area.

The work we will be doing

To continue for our preparation of the HS2 railway we will be completing works on Gilson Drive by installing traffic management to complete NGED connections and reinstatement works.

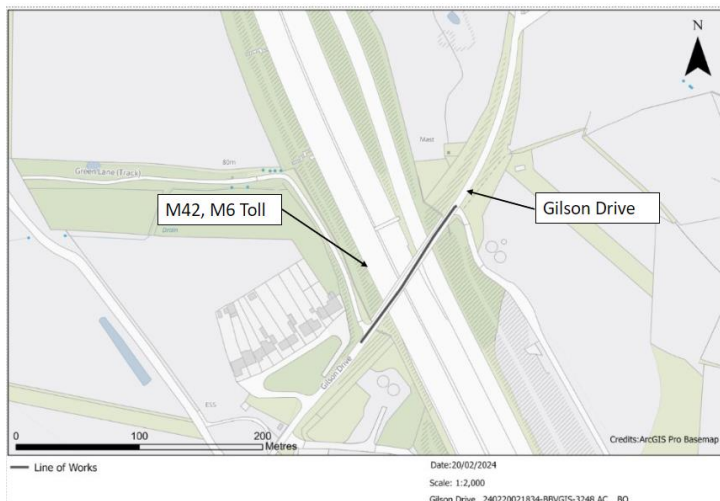
When the work will take place

A road closure will be in place on Gilson Drive each weekday from Monday 9 December to Friday 13 December. The closure will be in place from 7.30am to 17.30pm each day.

Access will be maintained to residents and deliveries using traffic management marshals.
