High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new railway in your area.

Temporary one lane closure on A47 Heartlands Parkway

As we progress with our works to construct the new HS2 railway in your area, we need to carry out road realignment works on the A47 Heartlands Parkway at the Aston Church Road roundabout. To complete the realignment, we will be putting in place a single lane closure from Aston Church Road roundabout to Saltley Viaduct roundabout for approximately 8 weeks

Preparatory works

To prepare for these works we need to close Aston Church Road roundabout from Saturday 4 January 9.00pm to Monday 6 January 6.00am. Following this there will be a single lane closure westbound from Aston Church roundabout to Saltley Viaduct roundabout from Monday 6 January 2025 for approximately 8 weeks.

To keep traffic moving in the area there will be a diversion route in place. Access to the Holiday Inn will be maintained via a specified signed diversion route.

Single lane closure in both directions on A47 Heartlands Parkway operational all day every day from Monday 6 January 2025 for approximately 8 weeks

Single lane closures

Saturday 8am -1pm

Our workforce can be on site up to 1 hour before and after to set up the site and to take down our work equipment
