High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As we progress with our works to construct the new HS2 railway in your area, we need to carry out some utility works. These works will include excavation of a section of Warren Road to allow us to install a duct crossing and manhole chambers.

Traffic management

To carry out these works safely we need to temporarily close a section of Warren Road from Monday 6 January to Sunday 24 January 2025 8:00am to 6:00pm. To keep traffic moving in the area there will be a diversion route in place.

Access to properties and businesses within the closure will be maintained at all times. Pedestrian access will also be maintained throughout the closure.

Where we will be working

We will be working along a section of Warren Road from the junction of Aston Church Road. Aston Church Road will remain closed.

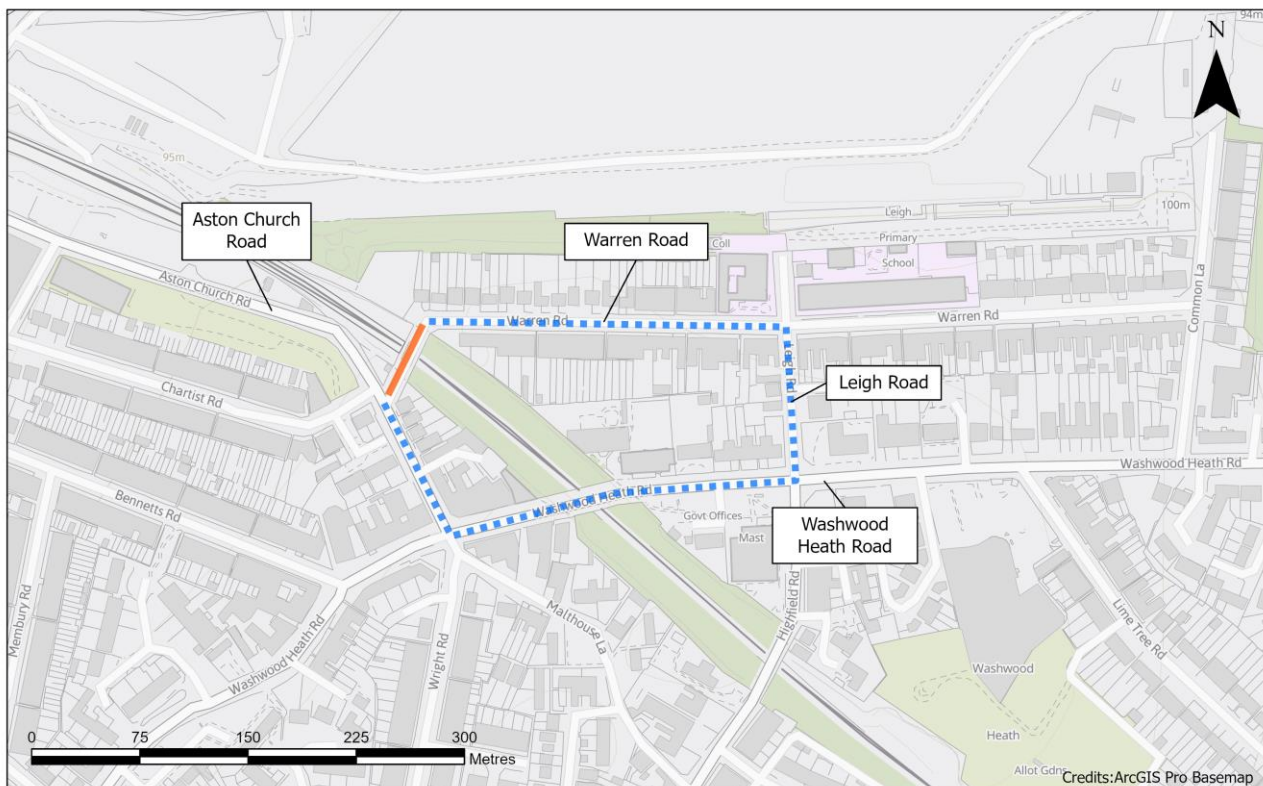
