



## Notice of overnight closure on Drayton Lane

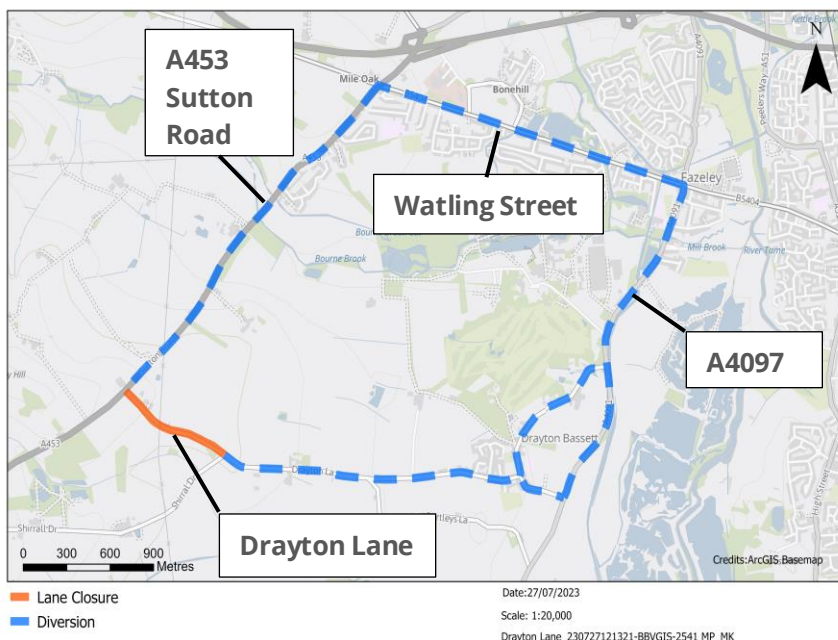
High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

### The work we will do

We recently transported large bridge deck beams that will form part of Drayton Lane overbridge. To complete the delivery safely we removed road signage to allow safe access for the large vehicle. The delivery of the bridge deck beams has now been completed, and we will now reinstate traffic signage and island which will require a short closure of Drayton Lane.

### When the work will take place

The full temporary closure of Drayton Lane will be in place on 9 and 10 December between **7pm to 12pm**. However, we plan to reopen the road as soon as our works have been completed.
