High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As we progress the new site exit for the HS2 construction compound we will install posts and road signage, in readiness for use early in 2025.

When the works will take place

The works will be carried out on two separate days, Wednesday 11 December and Friday 13 December, between 9.30am and 3.30pm.

What to expect

Temporary traffic lights on Stoneleigh Road and minimal disruption to your journey. Access for pedestrians and cyclists is unaffected,
