As we progress the new site exit for the HS2 construction compound we will install posts and road signage, in readiness for use early in 2025.

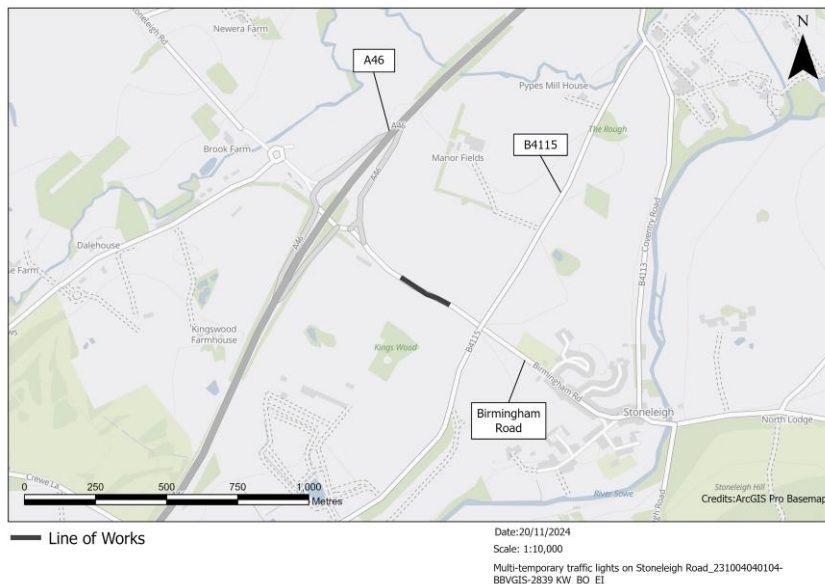
## When the works will take place
