High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

The work we will be doing

As part of the ongoing work to deliver the HS2 railway, we will be carrying out a series of trial holes and surveys for the highway drainage network in advance of the final road realignment. To do the work safely we will require temporary traffic lights.

When will these works be taking place

The four-way temporary traffic lights will be in place each day between **8am and 6pm from Monday 11 November to Friday 15 November 2024.**

What to expect

Temporary four-way traffic lights at the crossroads of Long Itchington Road and Welsh Road, near the Greenway car park. There will be minimal impact to journey times with full access for pedestrians and cyclist throughout the works. Please see the map on page two for full details.

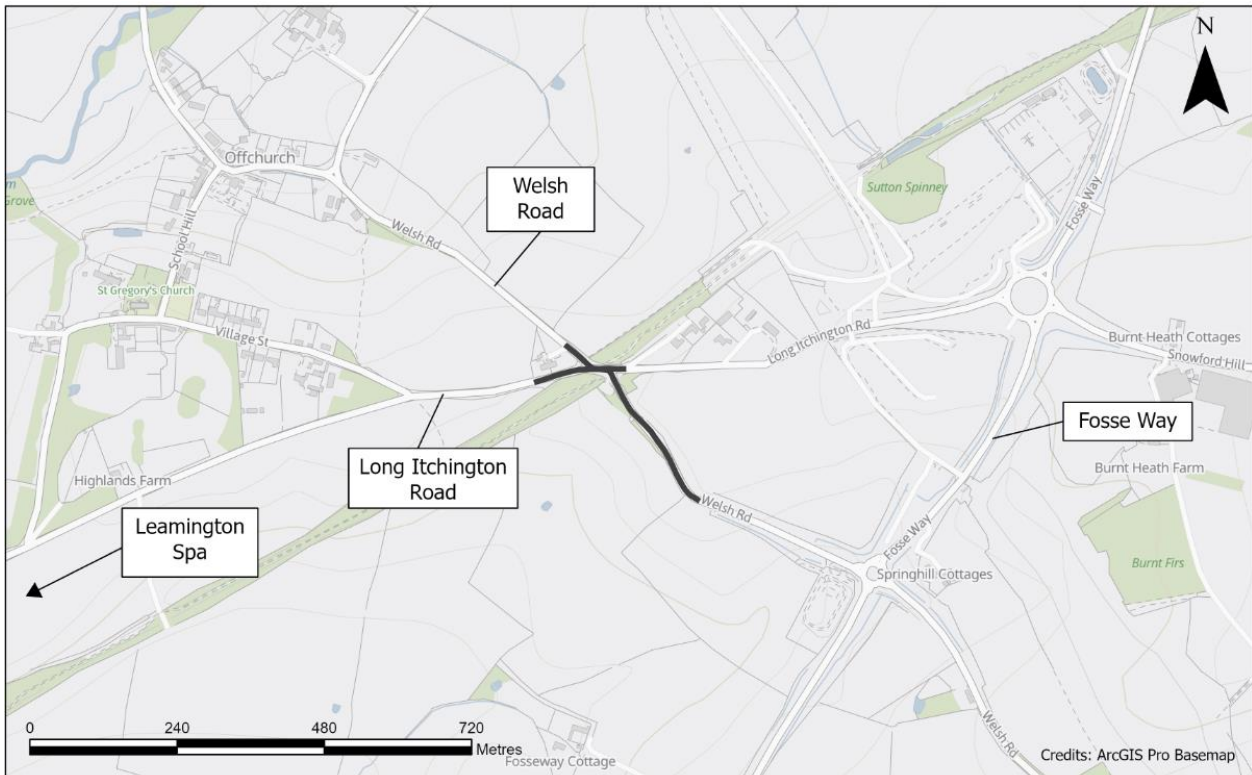
