

Lane closure on A413, Little Missenden

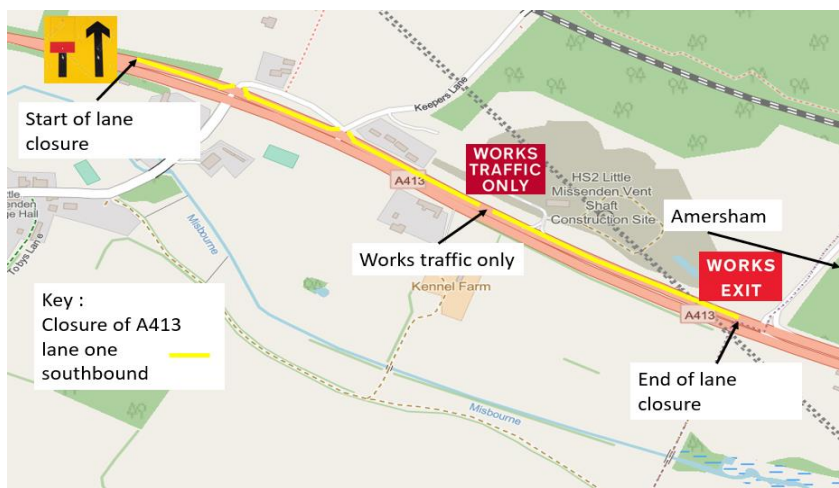
High Speed Two (HS2) is the new high speed railway for Britain. This notification is to inform you of a temporary lane closure on the A413, in Little Missenden, to undertake surveys around our site.

How will these works affect you?

We will close one lane of the A413 travelling southbound from Little Missenden towards Amersham to facilitate survey works. The other southbound lane will remain operational, and traffic management will be installed during the duration of the works. The lane closure will occur from 9.30am to 3.30pm on Monday 25 November.

What will we be doing?

We will be conducting surveys to ensure compliance with environmental regulations and to protect any existing wildlife and habitats. We will also be undertaking utilities surveys which are essential to map out future works. To undertake the surveys a section of the A413 lane one, southbound, will be temporarily closed and reopened once the surveys are complete. A small team will be present in the closed section.
