From late November until mid-December 2024 Station Road South will remain closed and there will be signed diversion routes in place. This is to allow BT Open Reach to continue utility works.

#### When will these works take place?

A section of Station Road South will be closed from Friday 29 November to Friday 20 December 2024.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Respond promptly to any complaints and take appropriate action.


# UPDATED Notice of Road Closures, crossroads of Station Road North and South and Quainton Road
