What are we doing?

In November, we will be continuing work on the verge of the newly aligned A418 Oxford Road. Some de-vegetation works will be carried out next to the new road, after it has opened to the public. Specifically, this will involve removing a tree next to the carriageway to accommodate a utility diversion.

Most of the work can be carried out without the need for traffic management and every effort will be made to keep holds on traffic to a minimum. Holds on traffic will occur during off-peak hours only.

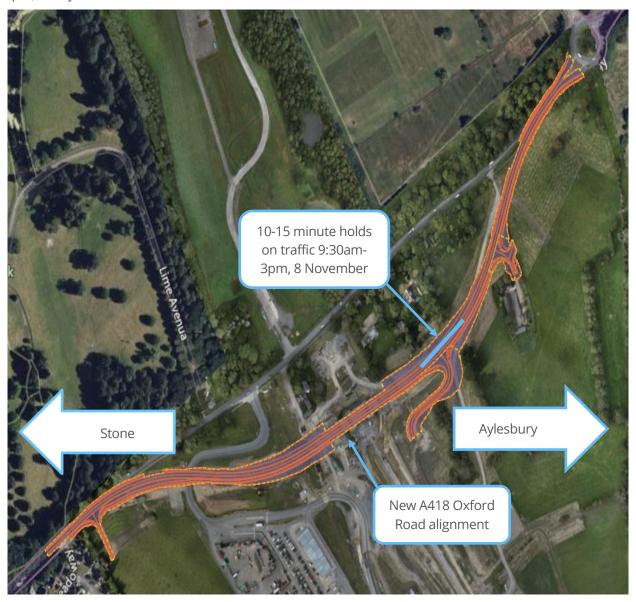
