



## Notice of cancellation of M42 motorway weekend closure and urgent overnight M42 northbound carriageway closure between junction 6 to 7a

High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

**Due to safety concerns relating to Storm Darragh, the planned M42 motorway closure between 6 to 9 December 2024, to allow for HS2 works between junction 6 and 7a (northbound) and junction 7 and 6 (southbound) has been cancelled by our partner National Highways.**

**The planned weekend closure for 13 to 16 December will still go ahead.**

### Urgent resurfacing works

As part of the routine motorway inspections undertaken by National Highways and BBV we have identified urgent resurfacing works which need to be completed on the M42 northbound carriageway between junction 6 to 7a.

To complete these works safely we will install an overnight closure on the M42 northbound carriageway, between junctions 6 to 7a on:

- Tuesday 10 December 2025

The overnight closure will be in place between 9pm to 5am.

A signed diversion route will be in place during these closures (see diversion map on page 2).

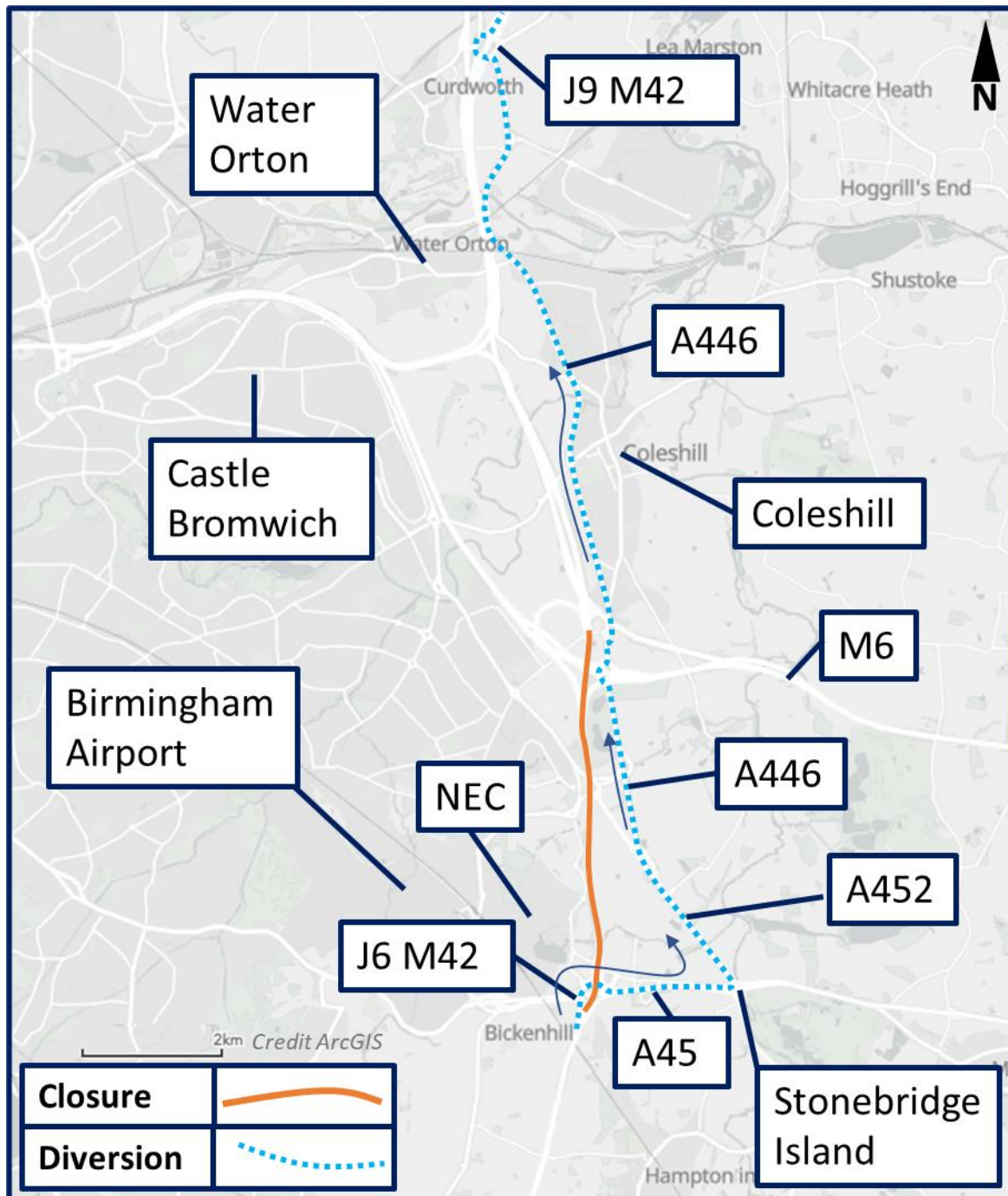

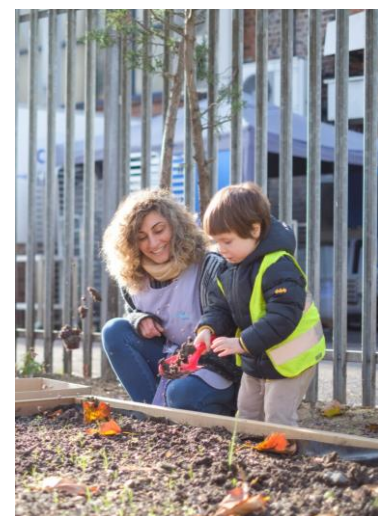
## About our Community and Business Funds
