High Speed Two (HS2) is the new high speed railway for Britain. If you have any questions about these works, please contact our Helpdesk to find out more. You can sign up for regular updates in your local area at www.hs2inbucksandox.co.uk.

What are we doing?

As part of our works, we will be constructing a plant crossing along the road known as Street through Fulwell, between Fulwell and Finmere.

A strengthened road surface will be created using concrete to ensure that we protect the road and any utilities underneath it for the duration of our works. As the preparatory works will require large plant and machinery, and time for concrete to set, we are required to fully close these sections of road, 24 hours per day.

All plant crossings, without exception, will be signal controlled. The traffic lights ensure safe, controlled crossing from our works sites across the highway.

When will these works take place?

A section of Street through Fulwell will be fully closed 24-hours a day from Monday 18 November to Monday 2 December. We will reopen the road as soon as possible.

Due to circumstances outside of our control, such as weather, these dates may be subject to change.

Duration of works

A section of Street through Fulwell will be closed 24hours a day from Monday 18 November to Monday 2 December.

Normal working hours: Monday to Saturday 8.00am – 6.00pm

What to expect

Varied activities with both quiet and busier periods. Road closures and some additional traffic.

Noise from plant and equipment used for the works.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.
