What are we doing?

We will be implementing a lane closure with 3-way temporary traffic lights at the junction of North End Road and Lee Road. This is to locate a Thames Water valve.

The existing closure of the lower part of Fiddlers Field/Snakes Lane from 2 January 2024 remains.

When will these works take place?

From Thursday 12 December to Thursday 19 December 2024 there will be 3-way temporary traffic lights at the junction of North End Road and Lee Road.

These dates may be subject to change due to circumstances outside of our control, such as weather. Please refer to the HS2 website regularly to check for any changes or updates.

Duration of works

From Thursday 12 to Thursday 19 December 2024.

Works will be carried out within normal working hours, however some additional evening or weekend working may be required when necessary.

What to expect

Lane closure with temporary traffic lights at the junction of North End Road and Lee Road.

Varied activities with both quiet and busier periods.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.

Provide a full diversion route for road users.

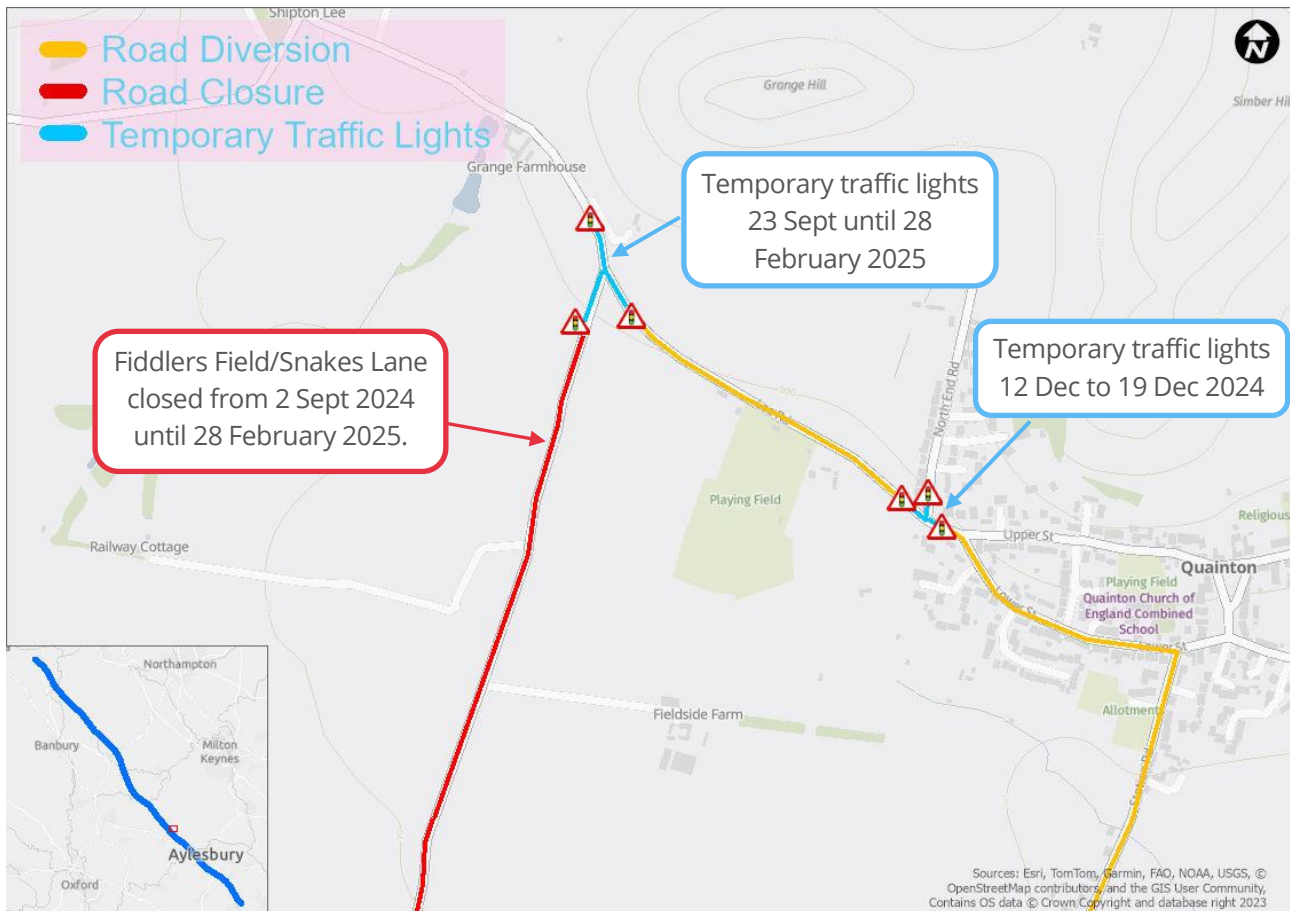
