High Speed Two (HS2) is the new high speed railway for Britain. Balfour Beatty VINCI (BBV) is working in partnership with HS2 Ltd to build the new high-speed railway in your area.

Upgrading the CCTV system on the A5 Hints Bypass

As we continue with our works to construct the A5 Hints bypass Overbridge that will allow HS2 to pass under the A5. To complete this work safely we have introduced a contraflow system. This is monitored 24 hours a day in the event of incidents or breakdowns; to continue the safe running of this roadworks scheme we need to undertake some upgrades to this CCTV system.

When will the work take place

To upgrade the CCTV system, we will have an overnight closure on the Eastbound A5 on:

- **A5 Eastbound carriageway** Wednesday 6 November 2024 from 9pm to 5am.

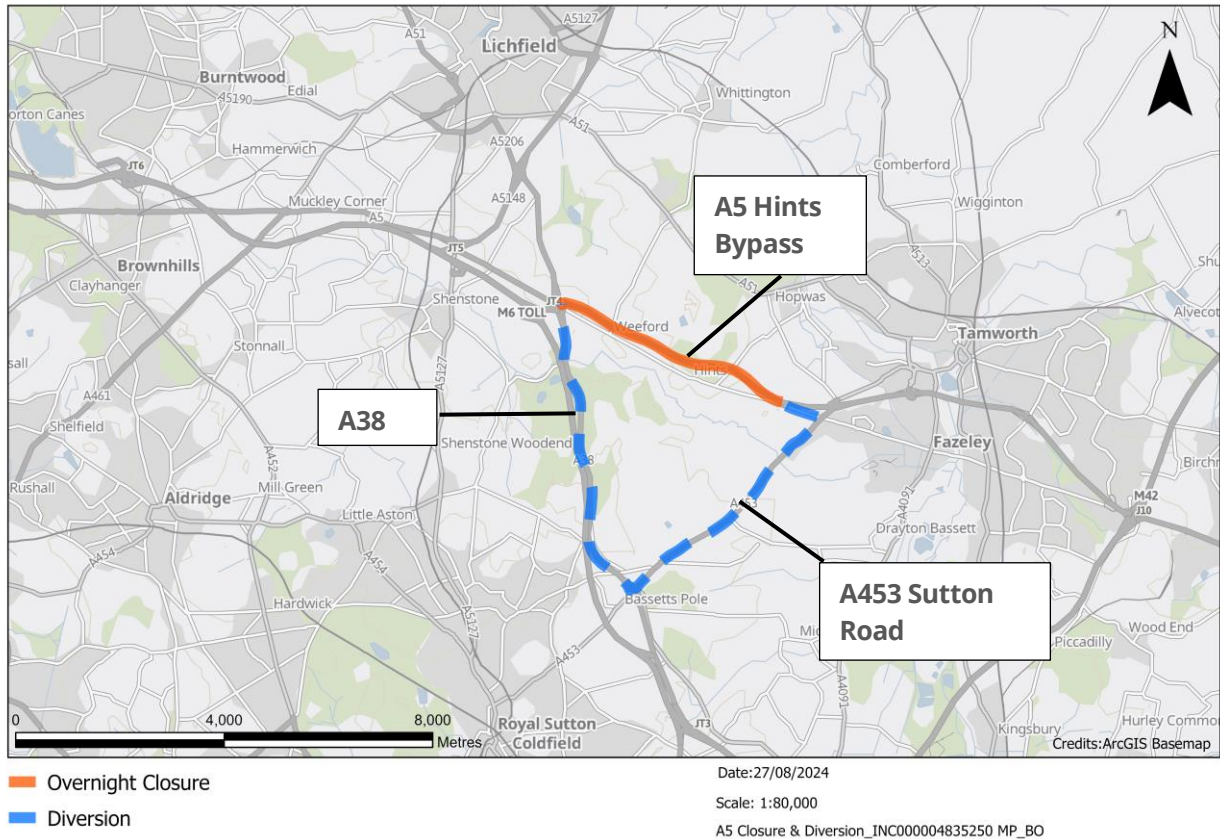
